**RE: Notification to the business partners, creditors, and the debtors of the Trelleborg Bohemia, a.s.**

Dear business partners of the company Trelleborg Bohemia, a.s.

We would like to inform you in accordance with section 2177 par. 2 of Act No. 89/2012 Coll., Civil Code, as amended, (hereinafter the "**Civil Code**"), that the company **Rubena Náchod, s.r.o.**, ID No. 09725351, with its registered seat at Českých bratří 338, 547 01 Náchod, file No. C 46769 maintained by the Regional Court in Hradec Králové (hereinafter the "**Rubena Náchod**"), as the acquirer, and company **Trelleborg Bohemia, a.s.**, ID. No. 00012131, with its registered seat at Akademika Bedrny 531/8a, Věkoše, 500 03 Hradec Králové, file No. B 91 maintained by Regional Court in Hradec Králové hereinafter the "**Trelleborg Bohemia**"), as the contributor, entered on 31 March 2021 into the agreement on contribution of enterprise to the registered capital, the subject of which is a contribution in-kind to the registered capital of Rubena Náchod by Trelleborg Bohemia which is the part of enterprise of Trelleborg Bohemia consisting among others of (i) **enterprise Náchod**, at the address Českých bratří 338, 547 36, Náchod, (ii) **enterprise Velké Poříčí**, at the address Náchodská 449, 549 32, Velké Poříčí a (iii) **enterprise Zlín**, at the address Šedesátá 5576, 760 01, Zlín (hereinafter jointly the "**Enterprise**").

In accordance with section 2180 paragraph 1 of the Civil Code, the acquirer, i.e. Rubena Náchod acquires the right of ownership to the Enterprise upon the publication of the information that a document on the contribution of the enterprise was filed in the Collection of Deeds of the acquirer, i.e. Rubena Náchod maintained by the Commercial Register. The transfer of the ownership to the Enterprise came into force on 1 April 2021 (hereinafter the "**Effective Date**").

In consequence of the transfer of the Enterprise, Rubena Náchod entered into all rights and obligations of Trelleborg Bohemia pertaining to the operation of the Enterprise as of the Effective Date. All monetary receivables and debts resulting from the contract(s) with your company pertaining to the Enterprise (hereinafter the "**Agreements**") arising after the Effective Date (inclusive), and any advance payments paid by your company and any advance payments provided by Trelleborg Bohemia on the basis of the Agreements shall pass to Rubena Náchod as of the Effective Date. The remaining receivables and debts under the Agreements, i.e. monetary receivables and debts incurred before the Effective Date, remain with Trelleborg Bohemia.

With regard to the above, we ask you to remit all payments of your obligations under the Agreements arising after the Effective Date (inclusive) to the accounts of Rubena Náchod, namely:


